#### GUIDE LINES FOR APPROACHING GRIEVANCE AND REDRESSAL CELL

#### I. Introduction

It is proposed to establish the Student, Staff and Faculty Grievance and Redressal Cell so as to keep the healthy working atmosphere and to uphold the dignity of the college by ensuring strife free atmosphere in the college to promote cordial student to student relationship. Student to Teacher relationship and Staff to Staff relations etc. This center also helps Students and Parents to record their complaints and solve their problems related to academics, resources and personal grievances.

#### II. Who can approach?

- Students with grievances which may relate to Assessment/Victimization/ Attendance/Charging of fees/ Harassment by colleague students or by teachers etc.
- Faculty with issues arising from their employment/un-disciplinary action among staff members/termination/ allegations.

### III. Mechanism of Solving Grievances

- A student/staff/faculty with a grievance can submit their grievance to one of the committee members orally/ in written / in drop boxes available at principal office and at Grievance cell coordinator room. The committee member will forward it to the Grievance cell coordinator.
- Grievance cell coordinator will call for a committee meeting on the issue received. Based on root cause of the issue, the genuinely of the grievance will be known before proceeding further in solving the grievance.
- Depending on the issue, a specific time frame will be decided to solve the issue.
- Committee members will process the issue and see that an acceptable/amicable solution is provided.
- Report on the grievance will be submitted to the Principal.

#### FUNCTIONS OF THE CELL

- 1. To solve students grievances which may relate to Assessment/Victimization/Attendance/ Charging of fees/ Harassment by colleague students or by teachers etc.
- 2. To solve faculty related issues arising from their employment/un-disciplinary action among staff members/termination/allegations.
- 3. To respond within specified time frame.
- 4. To monitor status and progress of Grievance-Redressal and shall furnish report on Grievance-Redressal position to the Principal.
